In Fiscal Year 2024, Huckleberry introduced a new mission statement and a *Theory of Change* which serves as a roadmap guiding us into the future. Centered on holistic, youth-focused care, our approach asserts that by meeting basic needs and providing consistent opportunities for growth in safe, welcoming spaces, youth will achieve stronger outcomes in the **Social Determinants of Health** advancing equity in their personal lives and the Bay Area community at large.

A ROADMAP FOR THE FUTURE

COMMUNITY-LED VISION: OUR THEORY OF CHANGE IN ACTION

This year, Huckleberry unveiled our comprehensive *Theory of Change* through powerful community conversations that demonstrated what authentic partnership looks like, especially in critical times. Grounded in social determinants of health across three key areas—health, social community, and neighborhood - our framework serves as both a north star and a blueprint for guiding our work.

We hosted two events bringing together community partners, funders, staff, Board members, and most importantly, young people for strategic conversations in San Francisco (SF) and Marin about advancing our new *Theory of Change*. The panels centered on deepening our impact while navigating current social and political realities. These conversations demonstrated our commitment to community-led solutions with young people's voices at the center of discussions about organizational strategy, partnership building, and collective action for social justice.

Our San Francisco gathering took place at the Presidio in a beautiful space generously provided by Futures Without Violence, featuring Chris Ballard (Executive Director, Coleman Advocates), Tionne (HYP program participant), and Yisroel Quint (Program Officer, Pacific Foundation Services).

In Marin, we partnered with Marin Community Foundation (MCF) and convened with MCF's Senior Program Director Shirin Vakharia, Yazuara (HYP program participant), and Judy Schwerin (Wellness Coordinator, San Rafael High School).

During our robust dialogue, young people like Tionne and Yazuara shared what makes our programs truly work: being seen "with real eyes" without judgment, having safe spaces, experiencing discussions rather than lectures, and finding trusted adults who share their struggles. As Chris Ballard noted, "It's an honor that young people are willing to open up to you" - highlighting the trust at the heart of our work.

Community partners emphasized that collaboration, not competition, creates the fastest path to real impact. Philanthropic allies reinforced the power of trust-based relationships, recognizing that nearly 60 years of community expertise means, "organizations know what they're doing."





JOURNEY TO JUSTICE NEW ZEALAND

TRANSFORMING YOUTH JUSTICE THROUGH GLOBAL LEARNING

Huckleberry's Director of Youth Justice, Kisai Henriquez, was invited to join the Zellerbach Foundation's recent Journey to Justice trip to New Zealand, a learning cohort bringing together juvenile justice system leaders, youth advocates, and community partners from San Francisco and Alameda counties. This initiative fosters collaboration, innovation, and a shared commitment to reimagining youth justice in the Bay Area.

GLOBAL INSPIRATION: LEARNING FROM NEW ZEALAND

During the week-long visit to New Zealand, participants explored the country's culturally-rooted, restorative youth justice system. Grounded in Māori traditions, New Zealand's model

emphasizes healing, accountability, family involvement, and community support over punishment or incarceration. These principles have informed restorative justice practices globally, and San Francisco is looking to these traditions to drive lasting change in the juvenile justice system, centering youth and their families.



THE JOURNEY TO JUSTICE TRIP EXPLORED:

- A restorative focus in juvenile justice: A deeper understanding of indigenous practices that prioritize restoration, healing, and focus on family involvement
- Immersive learning: Participants gained firsthand knowledge into effective, culturally responsive youth justice strategies that could possibly be implemented in San Francisco
- Local impact: Applying the lessons learned to accelerate transformational change in the Bay Area's juvenile justice system



Journey to Justice stands as a bold step toward a justice system that truly serves and uplifts youth, and is grounded in community, accountability, and care.





"My hope is that through this transformative trip, San Francisco and
Huckleberry Youth Programs can think expansively about what our youth need

Kisai shared her key insights from the trip at a recent SF Juvenile Probation Commission meeting which include:

- In New Zealand, youth from the Māori community make up 97% of those in youth court despite being only 20% of the population. This is in parallel to the disproportionate representation of African American and Black youth in our own systems in the United States.
- The Māori call for transformative change—centering Indigenous leadership, co-designing solutions, and decolonizing justice—offers a powerful model. Programs like Kotahi te Whakaaro demonstrate how cross-agency, community-led responses rooted in cultural perspectives can replace punitive systems and it was inspiring to see how these approaches could thrive in our local communities.
- Huckleberry Youth Programs is inspired to collaborate with community and system partners
 to center Black youth and families in service design, to abolish harmful systems, and expand
 alternatives to arrest and incarceration, while deepening wider Bay Area juvenile justice
 system collaboration, especially for the 30% of youth who live outside of San Francisco but
 are arrested here.







CA has led historic reforms in youth justice reducing youth detention statewide by 75%. San Francisco has outpaced this trend, decreasing youth incarceration rates by 78%, reflecting not only policy shifts but a growing recognition of the need to center youth voices and the effectiveness of community-based solutions like the Community Assessment & Referral Center (CARC).

Huckleberry Youth Programs recently celebrated 25 years of leading CARC, a nationally recognized model for juvenile justice diversion programs which has an average historic nonrecidivism rate of 80 to 85%.

SUPPORTING AND EMPOWERING MARIN COUNTY YOUTH AND FAMILIES

We partner with young people and families in Marin County as they navigate a range of life challenges, including trauma, economic hardship, and barriers to healthcare and language access. Many of the individuals we serve come from immigrant communities and bring with them deep resilience, wisdom, and cultural richness.

To ensure our services are responsive and inclusive, most of our team is bilingual in English and Spanish, and 71% of our staff identify as Latine. These shared experiences help us foster strong, trusting relationships and offer support that is welcoming, respectful, and rooted in understanding.

We have developed strong connections with Newcomer youth in Marin County, many of whom are adjusting to life in a new country while also coping with loss, separation, or uncertainty about their futures. There's a growing need for Spanish-speaking mental health providers in Marin, and while we offer counseling and case management, demand is high and waitlists are growing. We're working hard to fill the gaps and meet families where they are.



NEW WAYS TO SUPPORT MENTAL HEALTH

Instead of relying only on traditional therapy, we have expanded our approach to mental health. Our team collaborates across all programs—whether it's reproductive health, education, or case management—so young people can get the support they need in real time. We've also grown our health education workshops and peer groups that help youth manage stress, build community and a sense of belonging, and learn healthy ways to cope.



Young people aren't just receiving Huckleberry services. Staff work in solidarity with our youth and the youth are leading the way!

Our harm reduction workshops, now offered in three high schools, give students in Marin County the tools to manage their mental health, make safer choices, and know when and how to ask for help.







Huckleberry's Nuestra Salud (Our Health) trains Newcomer youth to become peer health educators. Participants lead school-based campaigns, raise awareness around mental and sexual health, and support their peers in reducing stigma and building resilience. It's powerful to see youth turning their experiences into leadership that

benefits their entire community.

HUCKLEBERRY ACE ACADEMY (Access to College Equity)

Congratulations to the Huckleberry ACE (Access to College Equity) Academy Class of 2025 on recently making college decisions! One hundred percent of ACE Seniors have committed to a college or university, and we are incredibly proud of their accomplishments.

HUCKLEBERRY'S Create2Activate: Creativity & Harm Reduction

In fiscal year 2024, we proudly launched a bold new initiative, **Create 2 Activate (C2A)**, with the support of a transformative \$600,000 grant from Elevate Youth California, a program of the CA Department of Health Care Services.



C2A is an 8-week journey allowing youth to use creative expression to promote substance use prevention. Through the production of Zines and documentaries, youth share real stories, evidence-based strategies, and bold visions for a healthier future. The program culminated recently with the premiere of *Just Breathe*, a youth-led documentary exploring vaping culture. This powerful piece reflects not only the skills youth gained in filmmaking and advocacy, but also the peer-to-peer trust at the heart of C2A.

HUCKLEBERRY YOUTH HEALTH CENTER'S BLOCK PARTY

Bringing Essential Youth Services and Basic Need Resources in the Haight

The first annual Huckleberry Youth Health Center Block Party was held in April 2024, bringing together hundreds of youth, community organizations, and service providers. The Center welcomed more than 150 attendees to the vibrant gathering and youth received health screenings and rapid HIV and HCV tests, and were connected to vital health resources by many of our community partners. The strong turnout underscored the ongoing need for accessible health care, housing support, harm reduction, queer community resources, and basic needs assistance.

The event stands as a testament to what can be accomplished when our community comes together with the shared mission of uplifting and supporting the health and wellbeing of San Francisco's youth. Health Center staff Keana Giles (left) and Jackie Miller were crucial to the Block Party's success.



HUCKLEBERRY'S HEARTS IN HARMONY BENEFIT Celebrating Impact & Community

The inaugural *Hearts in Harmony* benefit was held in April 2024 at The Chapel, where heartfelt testimonials from Huckleberry clients Jesse and Katelyn reminded us of the life-changing impact of Huckleberry's work. Jesse (pictured) shared, "I wouldn't be the man I am today without Huckleberry Youth Programs." More than \$159,000 (net) was raised.

In April 2025 the 2nd annual sold-out benefit was at the stunning Presidio Officers' Club and celebrated 25 years of CARC, our transformative juvenile justice diversion program. The evening featured powerful spoken word from the Poets Laureate of Oakland and Santa Clara County and a compelling keynote by Eddy Zheng of the New Breath Foundation, who spoke passionately about the importance of community-based support in helping young people thrive. More than \$170,000 (net) was raised in 2025!

Thanks to the generosity and passion of our community of donors, volunteers, and event sponsors our *Hearts in Harmony* benefits continue to grow and help us provide essential services for our youth and families!







AIDS WALK

Team Huckleberry raised more than \$10,000 including a generous \$5,000 grant from the AIDS Walk Foundation - our highest AIDs Walk total ever! Every dollar goes directly toward providing essential physical, reproductive, and mental health services to the young people we serve at our clinics.
